Rules & Regulations

Each company entered is led by a Team Captain, who registers the team, recruits participants, participates if they choose, manages communication to the team, and ensures day of activity assignments.

Participating companies use the event as a platform to promote health and fitness in the workplace, foster goodwill and camaraderie among their employees and show their commitment to the community.

Eligibility Rules

- Participants may register only as part of a company team - no individual entries will be accepted.
 - Team 1 – up to 20 participants: \$3,000
 - Team 2 – up to 20 additional participants: \$3,000
 - If a company has two teams, there is no swapping of team members permitted during the event.
- 30% of the participants must be made up of the minority gender of the team. For example, a 20 member team could be made up of 6 men and 14 women.
- Teams must be made up of at least 8 participants and no more than 20.
- The Boston Children's Hospital Corporate Cup is open to teams of employees from corporations, small and large businesses. Company and employee eligibility determinations shall be made exclusively by Boston Children's Hospital Corporate Cup. All decisions shall be final. Verification of eligibility must be provided upon request.
- Participants must be actively employed, working a minimum of 25 hours a week for at least three months prior to event day for the company they are representing.
- Participants must be at least 21 years of age as of the event date.
- Each participant must register online and sign a waiver in order to be officially entered and eligible to participate.

Event Rules

- Registration transfer will be available for participants until Monday, June 18, 2018.
- All teams will rotate through events on a timed schedule. 20 minutes will be allotted for each event, with a 10-minute transition period. It is the responsibility of the team captain to make sure the team is at the correct event at the beginning of the 20-minute session. The session will begin whether or not all teams are at their assigned event.
- All team members must compete in at least one event.
- All participants are required to sign a waiver prior to competing.

- The Boston Children's Hospital Corporate Cup reserves the right to delay, postpone, cancel, or not officially score any event in the event of extreme weather conditions. The determination of what constitutes extreme weather conditions is reserved to the Boston Children's Hospital Event Committee and the venue. **Entry fees are non-refundable and non-transferable, even in the case of event cancellation.**
- The Boston Children's Hospital Corporate Cup reserves the right to make additions, changes, or clarifications to these rules without prior notice to company teams or team members. The Boston Children's Hospital Corporate Cup will endeavor to advise teams of any rule change prior to the event, but any such change shall be considered binding upon all company teams and participants whether or not they have received notice of the change prior to the event.
- All rules are subject to interpretation by the Event Coordinator and Boston Children's Hospital Event Committee. All decisions of the Boston Children's Hospital Event Committee are final.
- The Boston Children's Hospital Corporate Cup reserves the right to reject or disqualify any entrant or team whose conduct is inappropriate to the spirit of the event. Individual disqualification may lead to the disqualification of the entire team and/or company for one or more events. It is expected that teams and team members will represent their company in the Corporate Cup events in a sportsmanlike and professional manner.
- There is absolutely no alcohol permitted at this event with the exception of the post event party. Participants found with alcohol will be disqualified and asked to leave the property.

Scoring Rules

- Teams with fewer than 20 participants will be scored on the same scale as teams with 20 participants.
- See event descriptions for additional scoring rules.

Violation of any of the rules indicated herein, in the Registration Packet, and/or in the event day announcements, may result in disqualification of any participant, team, and/or entire company for one or more events. The decision of the Boston Children's Hospital Event Committee is final. All aforementioned event rules were designed with the safety of the participants in mind.
